

Statement on roll product safety

Roll products made by Avery Dennison – Label and Packaging Materials are 'safe' products in accordance with the description given by Directive 2001/95/EC, Article 2(b). Note that safety data sheets, as referred to in Directive 1999/45/EC, Article 14 and Directive 91/155/EC, are not required for products generally recognized as safe.

Safety data sheets are also not required for products defined as 'articles', in compliance with Regulation (EC) No. 1907/2006. Products supplied by Avery Dennison – Label and Packaging Materials are 'articles' according to the definitions within this Regulation concerning REACH (Registration, Evaluation, Authorization and Restriction of Chemicals).

GENERAL INFORMATION

Health: To our best knowledge the product does not present undue health hazards under normal conditions of use, handling and storage.

Handling and Conversion: Normal safety principles in handling and conversion should be applied.

Application and use: The product is not intended for use in direct contact with food or prolonged contact with the human body unless expressly stated. To the best of our knowledge, standard Avery Dennison Roll products comply with the EC Toy standard EN 71/3.

Environment: None of the fibres used for our standard papers are bleached with elementary Chlorine. The products are manufactured without the use of ozone-depleting materials (ODMs). All standard Avery Dennison roll products comply with the US CONEG Model Toxics Legislation, the European Council Directive 94/62/EC on packaging and packaging waste, Article 11, and Directive 2000/53/EC, with reference to the acceptable levels of heavy metals (i.e. a sum of heavy metals Cadmium, Mercury, Lead and Chromium (VI+) less than 100 ppm).

Waste disposal: Generally, Avery Dennison materials can be disposed of by routine waste disposal through government-licensed facilities as is usual for ordinary waste materials. It is recommended, however, to participate where possible in one of the recycling projects for matrix waste or backing paper initiated by the FINAT Recycling Group. Details are available on request from FINAT secretariat.
