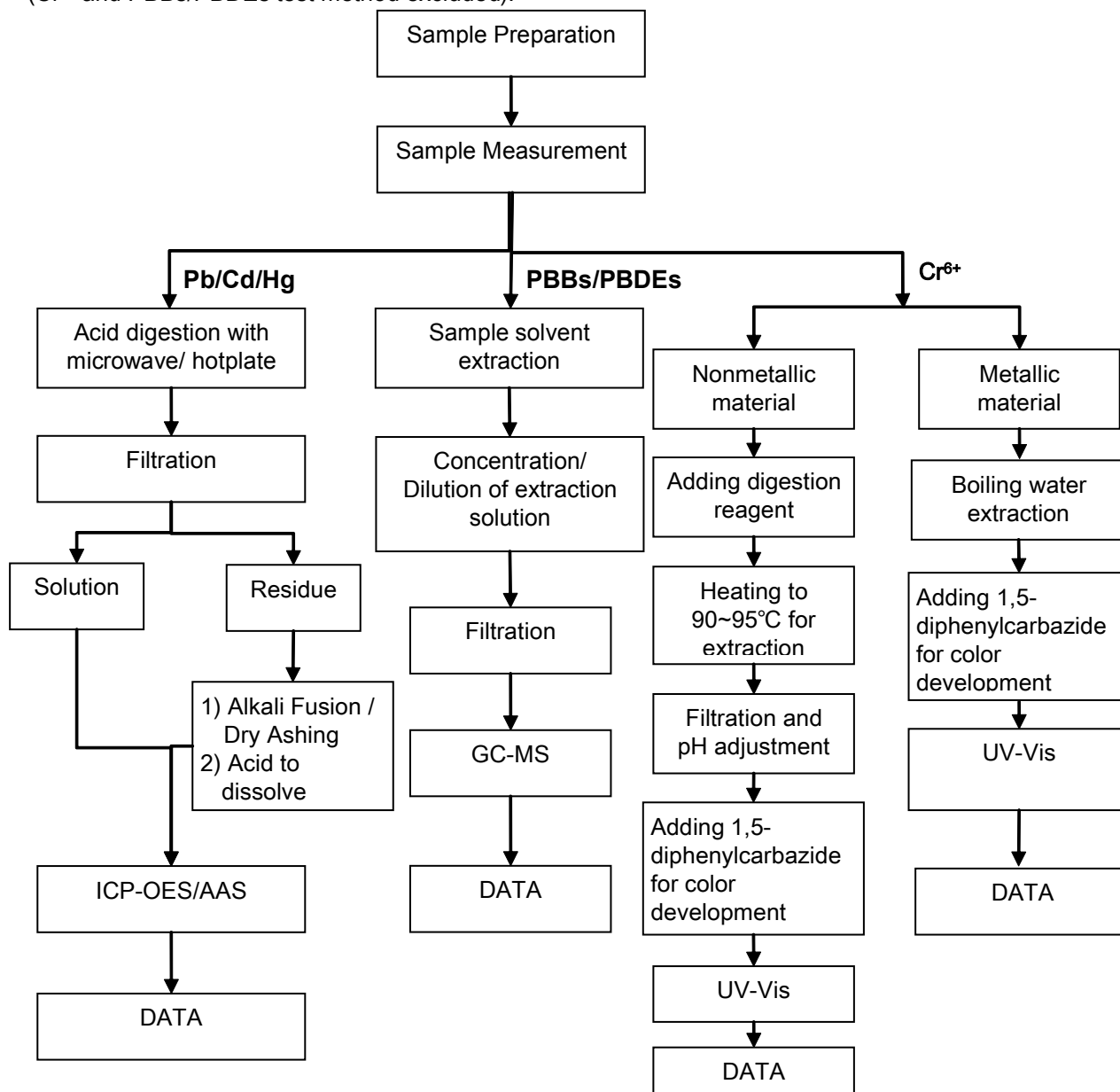

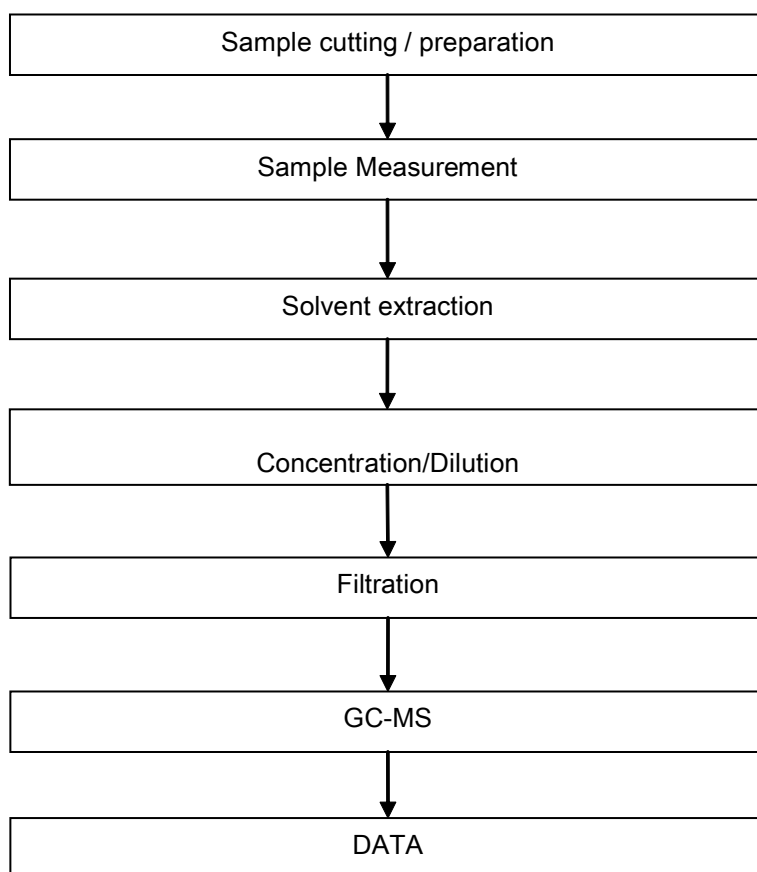

Phthalates Testing Flow Chart

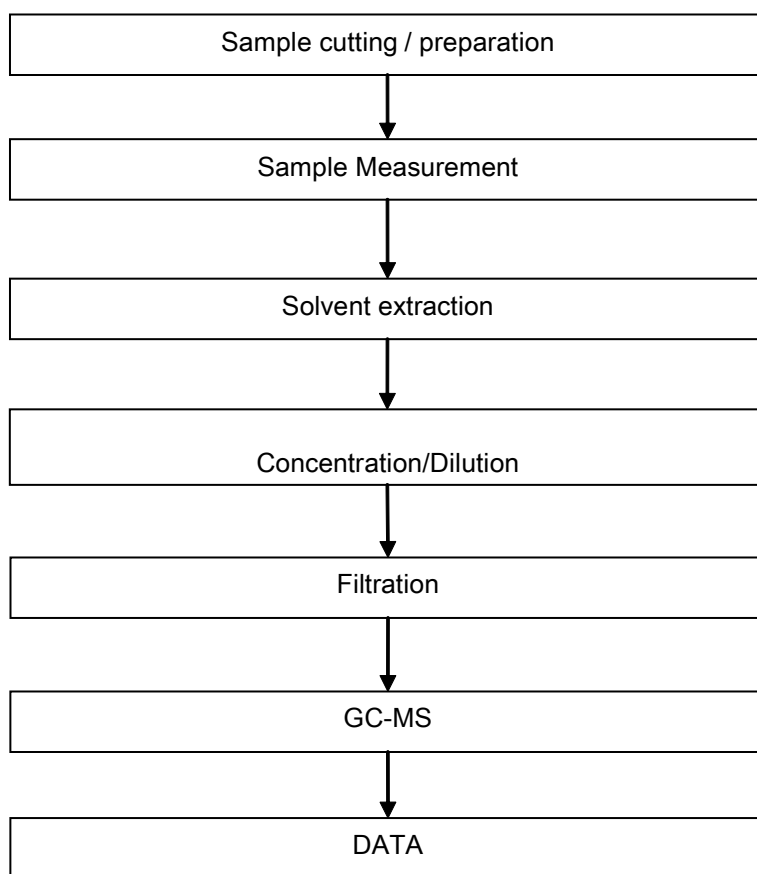

HBCDD Testing Flow Chart

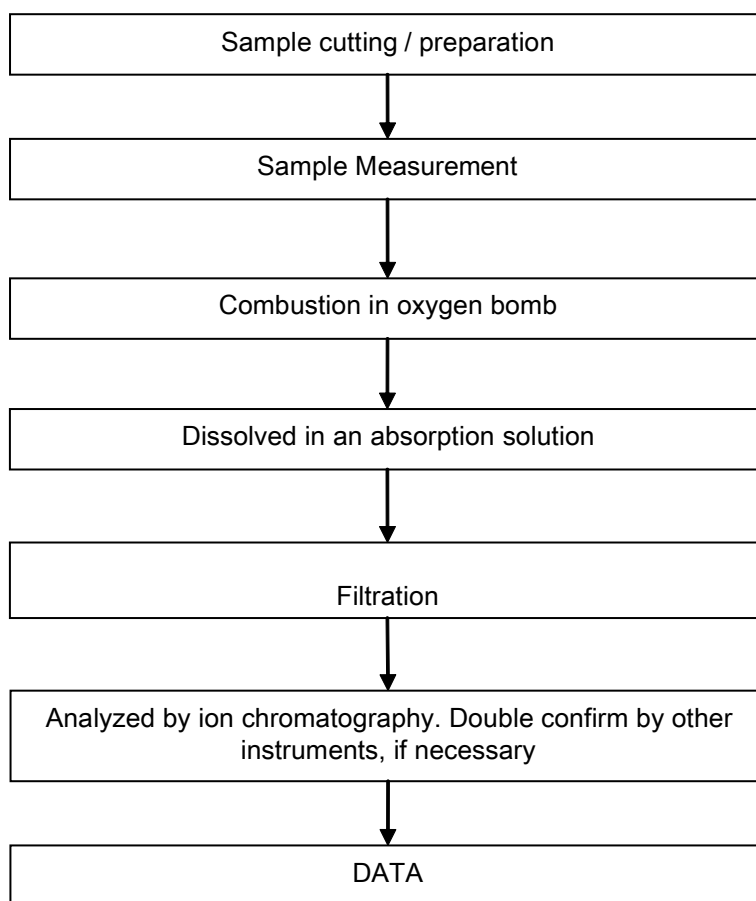

Halogen Testing Flow Chart

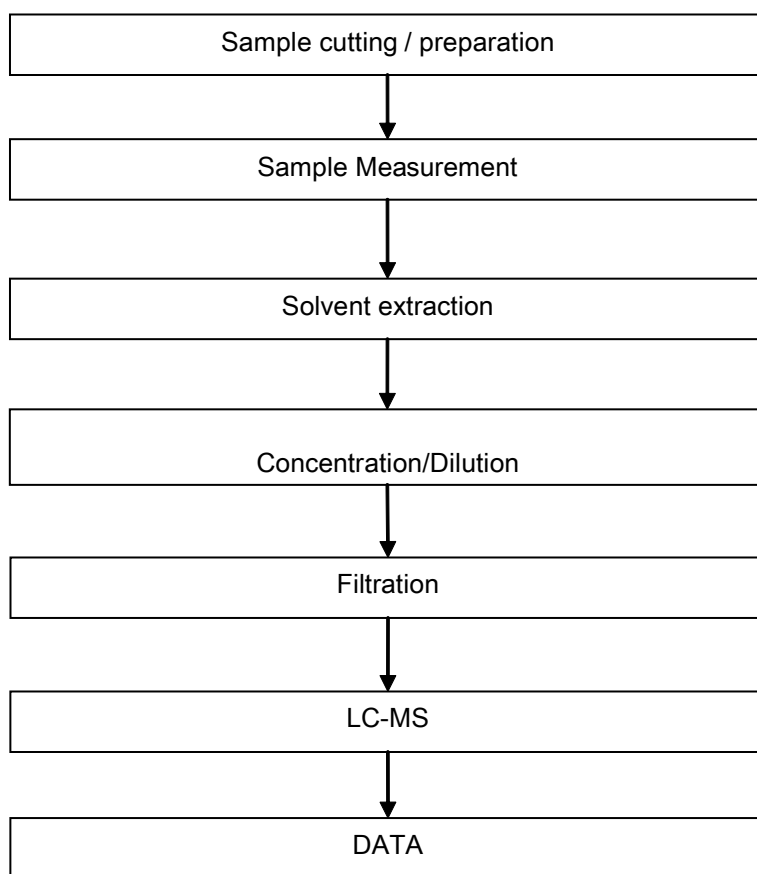
