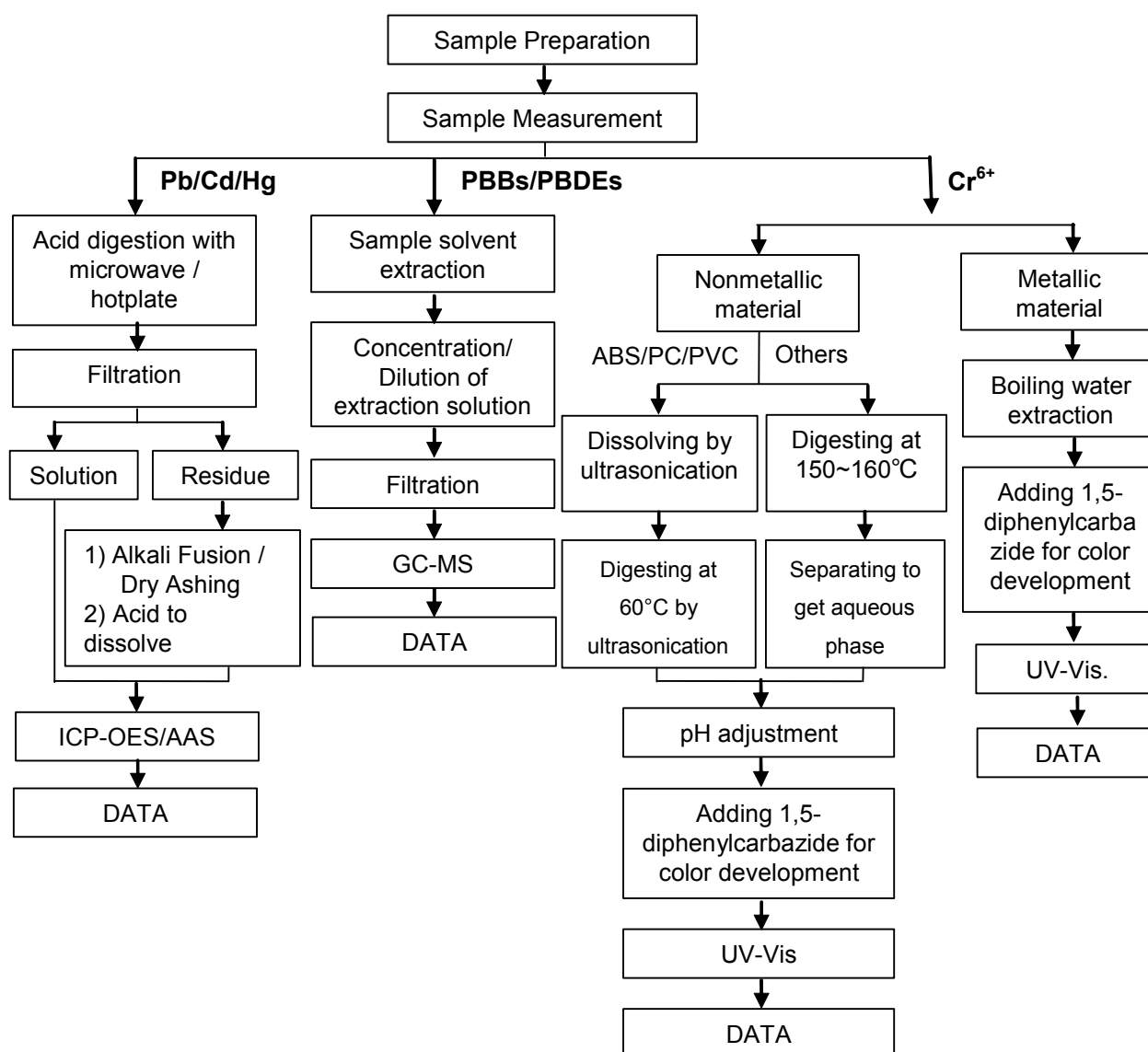

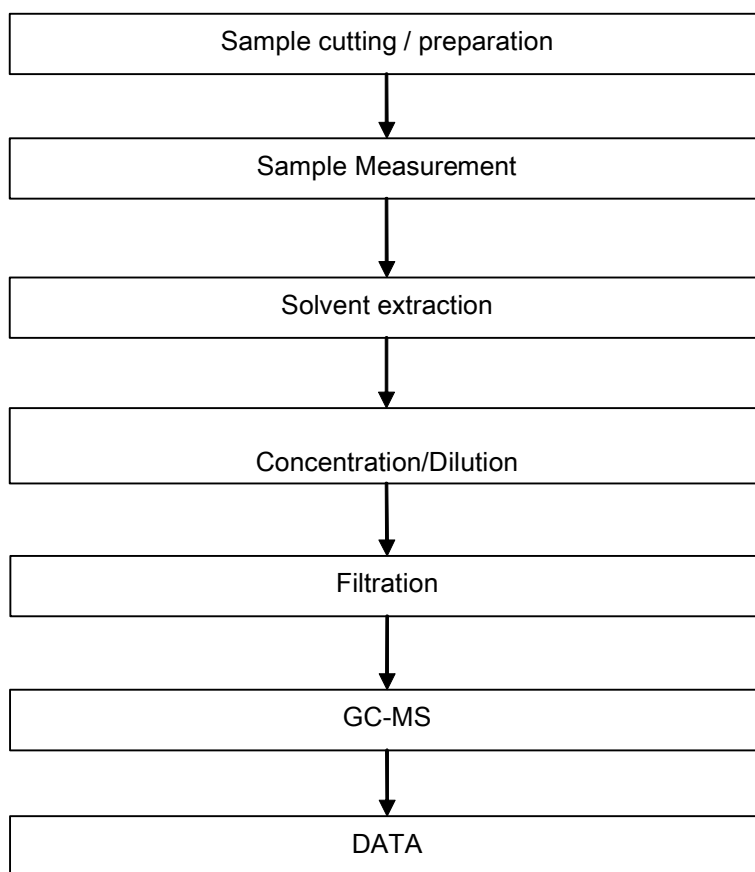

### Phthalates Testing Flow Chart

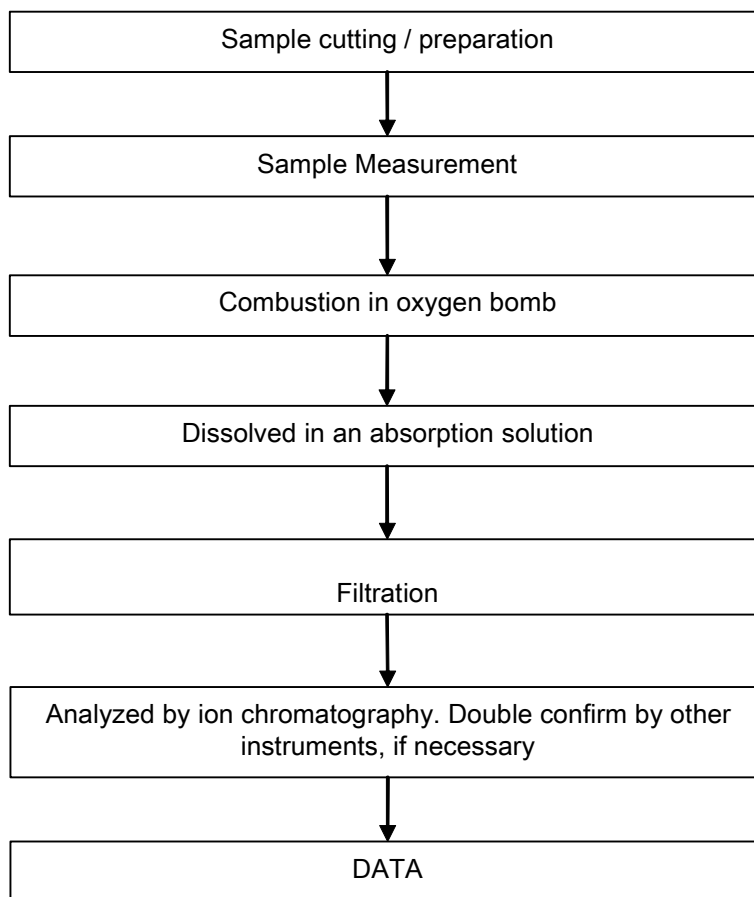

### Halogen Testing Flow Chart

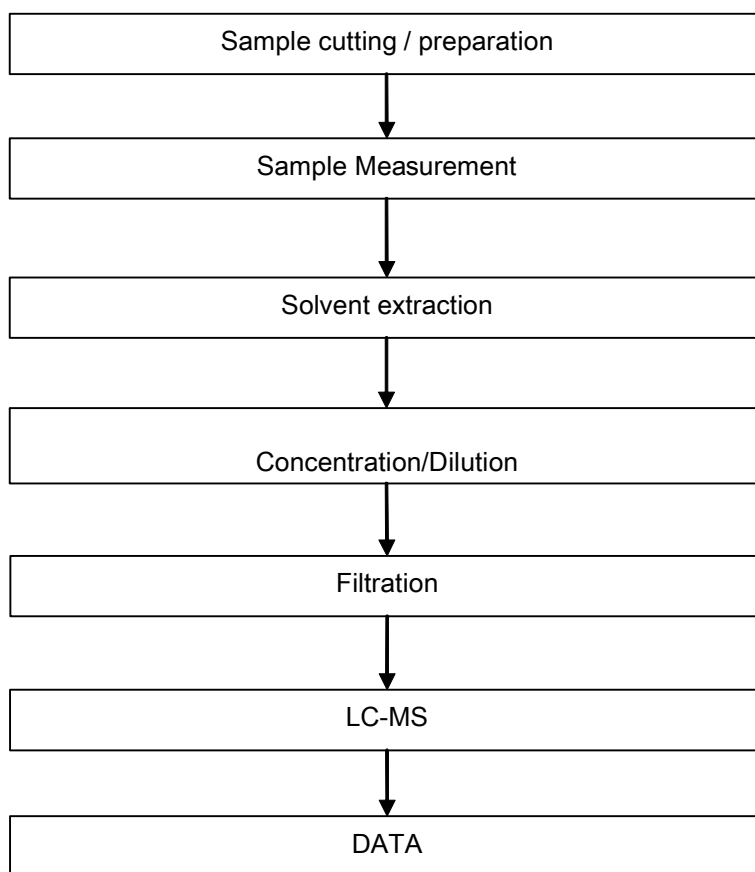

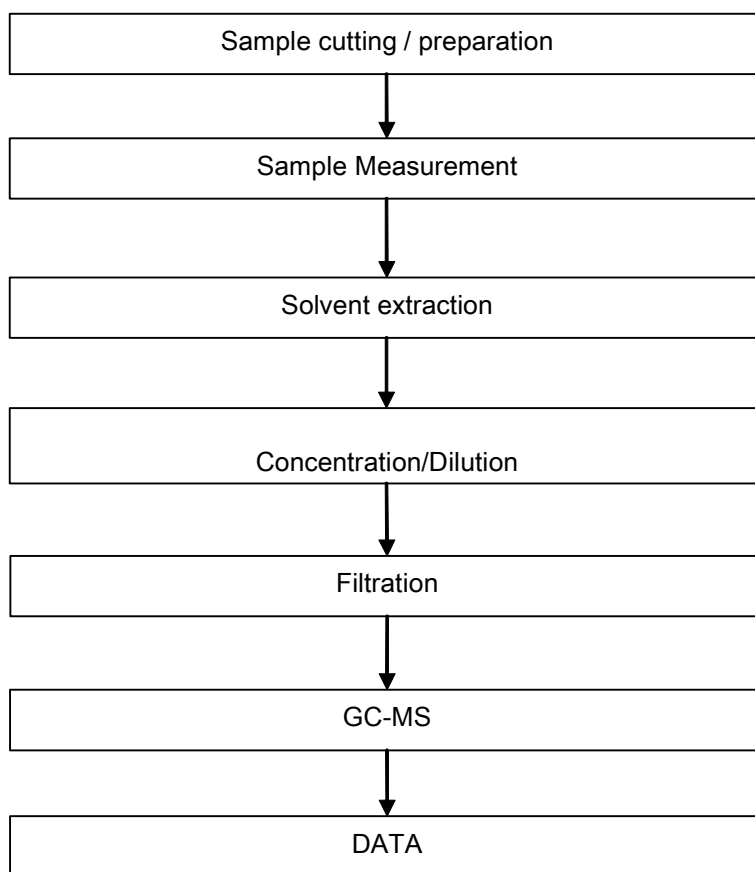

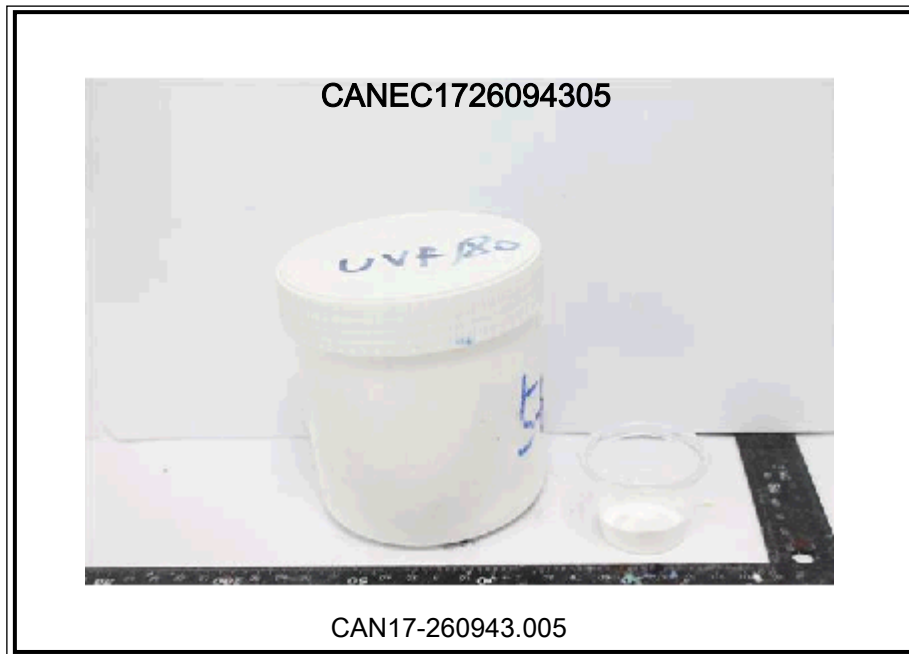
